Terrorist organizations (including guerilla, rebel groups) have a clear political orientation and their primary aim is to address perceived injustices through violence and intimidation tactics, while organized crime groups seek profit maximization and are rarely interested in changing the political status quo, unless it directly threatens their activities.

Recent work has demonstrated that terrorist and organised crime groups can function in very similar ways, for instance, by drawing members from the same social groups. Some authors have also contended that a terrorist group's (incidental) use of organised crime goes far beyond a mere pragmatic means to achieve funds, but is instead indicative of a metamorphic scale that exists between the two phenomena.
